This Information Security Management System (ISMS) is the means by which EBC Group (UK) Limited (the 'Organisation') satisfies the requirements of BS ISO/IEC 27001 : 2022 with regard to the Organisation's overall business risks. It specifies the requirements for the implementation of security controls, customised to the needs of the Organisation or to specific parts thereof.

The Organisation has adopted the process approach for developing, implementing and improving the effectiveness of its ISMS.

The Organisation, in adopting the process approach is committed to:

1. Understanding business information security requirements and the need to establish policy and objectives for information security
2. Implementing and operating controls in the context of managing the Organisation's overall business risk
3. Monitoring and reviewing the performance and effectiveness of the ISMS
4. Continual improvement based on objective measures
5. Communicate throughout the Organisation the importance of meeting all relevant statutory and regulatory requirements specifically related to its business activities
6. Ensuring that adequate resources are determined and provided to monitor and maintain the ISMS.
